

BELANGRIKE INLIGTING VIR DIE OORTREDER
(SYNDE DIE EIENAAR/BESTUURDER)

1. **Waarskuwing:** Die betaling van die bogenoemde boete moet voor of op 1. die bogenoemde betaaldatum geskied ten einde dagvaarding te vermy.
2. **Voorwaardes vir betaling van boetes:**
Met betaling van die boete:
2.1 Moet hierdie dokument die betaling vergesel.
2.2 Betaling kan slegs geskied by wyse van kontant, elektroniese oorplasing of poswissels.
2.3 Posorder of poswissels moet aan die betrokke owerheid uitgemaak word.
3. **Die boete kan alleenlik by betrokke Verkeers Departement betaal word.**
4. Volgens die bepaling van Artikel 73 van die Padverkeerswet 93 van 1996 word aanvaar dat die geregistreerde eienaar van die vermelde voertuig die bestuurder was. U word dienoreenkomstig die geleentheid gebied om die vasgestelde boete binne 30 dae vanaf kennisgewing hiervan by genoemde adres te vereffen in gebreke waarvan 'n dagvaarding uitgereik sal word.
5. Indien U skuld op die aanklag ontken, staan dit U vry om U teen die aanklag in die hof te verweer nadat 'n dagvaarding aan U beteken is.
6. Indien U die boete vermeld in hierdie kennisgewing betaal, sal die misdryf U nie as 'n veroordeling toegereken word nie.
7. In geval van navrae moet die kennisgewing nommer ssngehaal word.
8. **Verloë moet binne 7 dae gerig word.**
9. Indien U egter **NIE** die bestuurder was nie, versterk asseblief volle besonderhede van die verantwoordelike persoon in die toepaslike gedeelte.
(Binne 7 dae)

'n Verklaring moet die volgende besonderhede bevat:

- a. Volle naam en van
- b. Identifikasie OF Paspoort nommer
- c. Fisies adres en straat kode
- d. Pos adres en poskode
- e. 'n Kopie of 'n bestuurderslisensie moet aangeheg word by verklaring
- f. Indien 'n verteenwoordiger van 'n maatskappy, moet 'n kopie van die huur kontrak aangeheg word.

WARNING: The abovementioned fine must be paid on or before the abovementioned payment date to avoid being summoned

Condition for payment of fine:

When paying the fine:

- 2.1 This document is to accompany such payment.
- 2.2 Payment can only be made by means of cash, electronic or postal order.
- 2.3 Postal order or money orders must be made payable to the relevant authority.

The fine can only be paid at the relevant Traffic Department.

In terms of the provisions of Section 73 of the road Traffic Act 93, of 1996, the registered owner is presumed to have been the driver. You are accordingly offered the opportunity of paying the compounding fine within 30 days of the date hereof at the mentioned address, failing of which a summons will be issued.

If you do not admit guilt on the charge you are at liberty to defend yourself on the charge after a summons has been served on you.

Should you pay the fine mentioned in this notice the offence will not be taken into account at a conviction.

In case of enquiries, the notice number must be quoted.

Representation must be submitted within 7 days.

If you were **NOT** the driver, please provide full particulars of the person responsible in the space provided.
(Within 7 days)

An affidavit must be completed with the following information:

- a. Full name and surname
- b. Identification OR Passport number
- c. Physical address and street code
- d. Postal address and postal code
- e. A copy of extract of a driver's license must be attached to the affidavit
- f. If a proxy of a company of the leasing or rental agreement must be attached.
