Credit Control and Debt Collection Policy

- Pages 1 – 29 – Updated paragraph numbering
- Page 17 – Aligned indigent threshold to old age pay as per budget speech. Aligned arrangement criteria to new indigent threshold
- Page 20, 22 - Aligned indigent threshold to old age pay as per budget speech.

- That are held within the boundaries of Langeberg jurisdictional area.
- That contributes towards the economic growth of the area.
- That promotes the participation of local talent and interest groups.
 - The Municipality shall consider making a direct financial contribution towards festivals.
 - Services offered free of charge are also limited.
 - Interested groups who wish to apply for assistance for festivals shall also follow the prescribed procedural and substantive rules of this policy.
 - Festivals having the highest economic impact on a specific town / community will receive preference. “

- Page 10 – Paragraph Added: “Process”
 - Once applications are received, they will be listed and forwarded to all ward Councillors to confirm the existence of the organisation.
 - The Municipal Manager will establish a committee that will assist with verifying the application against the set criteria listed in the policy.
 - The delegate Chairperson must submit a report to the Council of the Municipality, containing.
 - particulars of each application that complies with the listed criteria and recommend:
 - (a) the amount of each award; and
 - (b) the name of the organisation or body to whom the award was made.
