CUSTOMARY INITIATION BILL [B 7B–2018]

The Western Cape Provincial Parliament's Standing Committee on Community Safety, Cultural Affairs and Sport invites stakeholders and interested parties to attend a public hearing on the Customary Initiation Bill [B 7B–2018] being organised as part of the Standing Committee's constitutional responsibility.

The purpose of the Bill is to protect, promote and regulate initiation by providing acceptable norms and standards for structures at national and provincial levels with a view to ensure that initiation takes place in a controlled and safe environment. The Bill also provides for the protection of life and the prevention of any abuse, it provides clarity on the various responsibilities, roles and functions of the key role players in customary initiation, and it makes provision for the effective regulation of initiation schools.
