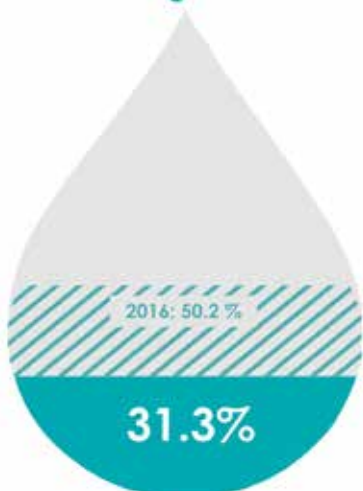

Water scarcity a serious issue in Langeberg

'You could be fined or face serious penalties for using water recklessly'



Low dam level: The Brandvlei dam level is under strain.

Langeberg Municipality and its residents are currently experiencing a Stage 2 water restriction period that could last indefinitely.

Households in all five towns are urged to use less than 15 000 litres of water per month.

Stage 2 entails the following restrictive measures that all residents must adhere to:

a. Suspension of all irrigation water ("leiwat") in McGregor and Robertson.

- b. No watering of gardens using municipal water.
- c. If households use more than 15 000 litres of water per month, they will fall into a higher water tariff bracket (100% increase on normal tariffs). This includes indigent households.
- d. No watering of sport fields, cricket pitches, golf course greens and/or bowling greens are permitted unless own source of water is used.
- e. No filling of swimming pools.
- f. No washing of vehicles with any hose will be permitted including commercial enterprises whose business it is to wash cars.

According to the Water By-Law, which was advertised in the Provincial Gazette in 2010, when an authorised official finds that a provision of this by-law is contravened, the official may issue a compliance notice to the consumer.

A notice issued to a consumer must state the measures that must be taken to rectify the contravention.

For Example: If a consumer waters their garden using municipal water and an authorised official finds out about this, then an official compliance notice may be issued to the consumer.

The notice could state a warning has been given for failing to comply with the restrictive measures. If the consumer contravenes any of these measures again, and is found guilty, then he or she may be issued with a fine, imprisonment or both.

If the consumer doesn't adhere to any of the provisions in the By-Law, the municipality may impose the following restrictive measures:

- Order a consumer at his own expense to install a meter and device for restricting the flow of water.
- Discontinue or limit the supply of water to the household.

If a consumer is to be found guilty of contravening or failing to comply with any provisions of this Water By-Law or compliance notices served by an authorised official, he or she may be liable on conviction to:

- A fine of R2 500
- Three years imprisonment; or both.

Waterskaarste 'n ernstige probleem in Langeberg

'U kan beboet word of ernstige straf in die gesig staar indien u water onverantwoordelik gebruik'

Langeberg Munisipaliteit en sy inwoners ervaar tans 'n Fase 2 waterbeperkingsperiode wat onbepaald kan voortduur.

Huishoudings in al vyf dorpe word aangemoedig om minder as 15 000 liter water per maand te gebruik.

Fase 2 behels die volgende beperkende maatreëls wat alle inwoners moet nakom:

- Opskorting van alle besproeiingswater ("leiwater") in McGregor en Robertson.
- Geen natmaak van tuine deur van munisipale water gebruik te maak nie.
- Indien huishoudings meer as 15 000 liter water per maand gebruik, sal hulle in 'n hoër watertarief-kategorie val (100% verhoging op normale tariewe). Dit sluit behoeftige huishoudings in.
- Geen natmaak van sportvelde, krieketvelde, gholfbane en/of rolbalbane word toegelaat tensy eie waterbron gebruik word.
- Geen opvul van swembaddens.

- Geen was van voertuie met enige tuinslang sal toegelaat word nie, insluitende kommersiële ondernemings wie se besigheid dit is om motors te was.

Volgens die Waterverordening, wat in 2010 in die Provinsiale Gazette geadverteer is, kan 'n gemagtigde beampte 'n voldoeningkennisgewing aan 'n verbruiker uitreik indien die beampte bevind dat die verbruiker 'n bepaling van hierdie verordening oortree het.

'n Kennisgewing wat aan 'n verbruiker uitgereik is, moet die maatreëls aandui wat geneem moet word om die oortreding reg te stel.

Byvoorbeeld: Indien 'n verbruiker hul tuin met munisipale water natmaak, en 'n gemagtigde beampte vind hiervan uit, kan die beampte 'n voldoeningkennisgewing aan die verbruiker uitreik. Die kennisgewing kan aandui dat 'n waarskuwing gegee was vir die versuim om aan die beperkingsmaatreëls te voldoen. Indien

die verbruiker weer enige van die maatreëls oortree en skuldig bevind word, kan hy of sy 'n boete of tronkstraf ontvang; of beide.

Indien die verbruiker nie aan enige van die bepalings van die Verordening voldoen nie, kan die munisipaliteit die volgende beperkende maatreëls oplê:

- Die verbruiker beveel om, op eie onkoste, 'n meter en 'n toestel wat die vloeï van water beperk, te installeer.
- Staak of beperk die toevoer van water aan die huishouding.

Indien 'n verbruiker skuldig bevind word aan 'n oortreding of versuim om by enige bepaling van die Verordening of voldoeningkennisgewing wat deur 'n gemagtigde beampte uitgereik was te hou, kan hy of sy by skuldigbevinding aanspreeklik wees vir:

- 'n Boete van R2 500
- Drie jaar tronkstraf; of beide.

'Ungadliwa okanye ujongane nezohlwayo ezikhulu ukuba uwasebenzisa ngokungenangqiqo'

UMasipala waseLangeberg kunye nabahlali bakhona kungoku bajongene neNqanaba lesi-2 Lemiqathango Yokusetyenziswa kwamanzi ntolayo enokubanjalo ixesha elide.

Indlu kuzo zontlanu iidolophu iyabongozwa ukuba isebenzise ngaphantsi kweelitha ezingama-15 000 zamanzi ngenyanga.

Inqanaba lesi-2 liquka lamanyathelo okuthintelwa kokusetyenziswa kwamanzi alandelayo nekufuneka bonke abahlali bahambisane nawo:

- Ukunqunyanyiswa kwayo yonke imibhobho yokunkcenshela ehamba phantsi komhlaba ("i-leiwater") eMcGregor naseRobertson.
- Akukho kunkcenshela kweegadi kusetyenziswa amanzi kamasipala.
- Ukuba indlu isebenzisa ngaphaya kweelitha ezingama-15 000 ngenyanga, izakufakwa kuhlelo oluphezulu

Iweentlawulo zokusetyenziswa kwamanzi (unikwe umdliwo wekhulu ekhulwini kunentlawulo eziqhelekileyo). Oku kuquka nezindlu zabahlwempuzekileyo.

- Akukho kunkcenshela kwamabala ezemidlalo, amabala ebhola yeqakamba, okuluhlaza kumabala egolufa, okuluhlaza kumabala ebhola eqenqwayo, ngaphandle kokuba usebenzisa awakho amanzi.
- Akukho kugcwaliswa kwamaqula okuqubha.
- Akukho kuhlanjwa kweemoto ngemibhobho nokuba ngeyaluphina uhlobo kuquka namashishini ashishina ngokuhlamba iimoto.

Ngokuvisisana noMthetho woMgaqo-Nkqubo Wamanzi, nowawupapashwe kwiGazethi yePhondo ka2010, xa igosa eligunyazisiweyo lifumanisa ukuba isahlulelo esithile salomgaqo-nkqubo saphulwe, igosa elo linganika isaziso sokuyalela ukuthotyelwa komgaqo-nkqubo ngumsebenzisi-manzi Isaziso esinikwe umsebenzisi-manzi kufuneka sichaze amanyathelo ekufuneka

athathwe ngulowo ungumsebenzi ukulungisa imeko yokwaphula umthetho.

Umzekelo: Ukuba umsebenzi-manzi unkcenshela igadi yakhe esebenzisa amanzi kamasipala lize igosa eligunyazisiweyo lifumanise oko, ngoko isaziso esisemthethweni sokuthobela singanikwa lowo ungumsebenzi. Isaziso singathi isilumkiso sikhutshwe kuba wohlulakele ukuthobela amanyathelo okusetyenziswa kwamanzi. Ukuba umsebenzi wamanzi wophula eminye yala manyathelo kwakhona, kwaye ufunyenwe enetyala, ngokoke anganikwa umdliwo, avalelwe okanye zombini.

Ukuba umsebenzi wamanzi akahambisani nazo neziphina izibonelelo zoMgaqo-Nkqubo, uMasipala unakho ukunyanzelisa lamanyathelo okusetyenziswa kwamanzi:

- Ayalele ukuba umsebenzi wamanzi ngendleko zakhe afakele ibhokisi yemitha nesixhobo esizakuthintela ukubaleka kwamanzi.
- Awavale okanye akulinganisele amanzi ozawafumana kweyakho indlu
- Akunike okanye, okanye uzifumane zozibini

McGregor se R100m Behuisingsprojek byna voltooi

Meer as 150 behuisingsbegunstigdes van McGregor het reeds in hul nuwe huise ingetrek, aangesien die dorp se grootskaalse behuisingsprojek byna voltooi is.

Langeberg Munisipaliteit is in die proses om sleutels aan kwalifiserende begunstigdes te oorhandig soos voltooide huise beskikbaar gestel word.

Alle kwalifiserende begunstigdes sal deur die munisipaliteit gekontak word, waarna 'n behuisingsbeampte die besonderhede van die oorhandigingsproses aan hulle sal verduidelik.

Wilson Nel, Behuisingsbestuurder by Langeberg Munisipaliteit, sê die projek bestaan uit 496 gesubsidieerde behuisingseenhede, maar aangesien daar nie genoeg goedgekeurde begunstigdes is nie, slegs 418 nou gebou sal word.

“Die oorblywende aantal is 78 eenhede waarvan 10 gereserveer sal word vir Verbeterde Gediens Persele vir diegene wie R3 501 to R7 500 verdien, as 'n eenmalige subsidie. Die ander 68

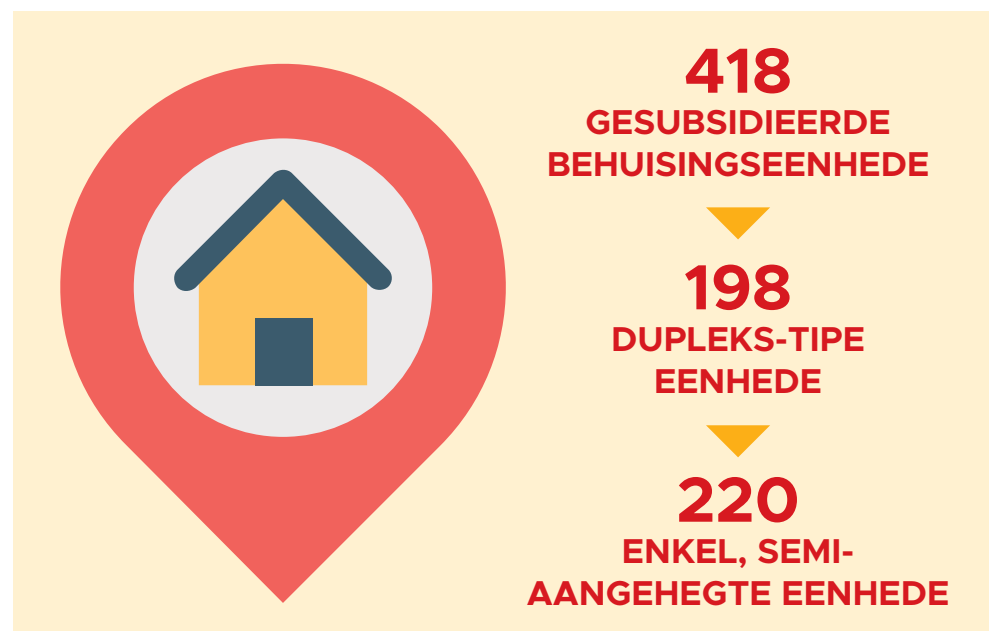
eenhede sal gebou word sodra ons genoeg begunstigdes ontvang,” het Nel gesê.

Die 418 behuisingseenhede sal uit 198 dupleks-tipe eenhede en 220 enkel, semi-aangehegte eenhede bestaan. Sommige van die huise sal anders ontwerp word om vir gestremdes voorsiening te maak.

Voltooide huise sal voor die einde van die jaar okkupeer word. Die gestremde begunstigdes sal teen die einde van Februarie volgende jaar sleutels van hul huise ontvang, aangesien die goedkeuring van die planne langer geneem het vanweë die bykomende ontwerpe.

Nel verduidelik dat die projek McGregor se behuisingsnood net gedeeltelik aanspreek aangesien dit slegs voorsiening maak vir persone wie tot R3 500 per maand verdien. Hy het bygevoeg dat hulle steeds opsies ondersoek om nie-kwalifiserendes te help. “Die behoefte aan behuising in hierdie streek is steeds baie groot. Daar is 9 285 persone op ons databasis wat deur die provinsie gehou word,” sê Nel.

Met hierdie hoë getal mense op die Langeberg Behuisingswaglys, is dit duidelik dat uitdagings as gevolg van hierdie groeiende kommer ontstaan.



Die unieke faktor van hierdie projek is dat dit, behalwe die wooneenhede, ook 'n bykomende 35 erwe het vir verskeie ander ontwikkelings. Hierdie nuwe ontwikkeling sal ook oor verskeie openbare oopruimtes spog vir gemeenskaplike tuine en parke, asook 'n gemeenskapsfasiliteit wat vir

gemeenskapsontwikkelingsdoelindes verhuur sal word.

Die McGregor Behuisingsprojek sal na verwagting teen einde Februarie 2018 voltooi wees, waarna alle kwalifiserende begunstigdes 'n splinternuwe huis sal ontvang.



MCGREGOR'S R100M HOUSING PROJECT NEARS COMPLETION



More than 150 housing beneficiaries from McGregor have already moved into their new homes, as the town's large-scale housing project nears completion.

Langeberg Municipality is currently in the process of handing over keys to qualifying beneficiaries, as completed houses become available.

All qualifying beneficiaries will be contacted by the municipality, whereby a housing official will explain the details of the hand-over process to them.

Wilson Nel, Housing Manager at Langeberg Municipality, said the

project consists of 496 subsidy housing units, but since there aren't enough approved beneficiaries, only 418 units will be built for now.

"The left-over figure will be 78 units. Ten will be reserved for Enhanced Serviced Sites for those earning R3501 to R7500 as a once off subsidy. The other 68 units will be built once we receive enough beneficiaries," said Nel.

The 418 housing units will consist of 198 duplex type units and 220 single semi-attached units. Some of the houses will be designed differently to accommodate the disabled beneficiaries.

Completed houses will be occupied before the end of the year. The disabled

beneficiaries will be receiving keys to their homes by the latest end of February next year, because the approval of the plans took longer with the additional designs.

Nel explained that this project will only partly address the housing need in McGregor as it will only cater for those persons earning up to R3 500 per month. He added that they are still looking at options to assist the non-qualifiers.

"The need for housing in this region is quite large still. There are 9 285 persons on our database which is kept by province," said Nel.

With this high figure of people on the Langeberg Housing Waiting List, it is

clear that challenges arise due to this growing concern.

The unique factor of this project is that besides the housing units, it also has an additional 35 erven for various other type of developments. This new development will also boast various public open spaces for communal gardens and parks, as well as a community facility which will be leased for community development purposes.

The McGregor Housing Project is expected to be completed by end February 2018, after which all qualifying beneficiaries will have received a brand new house.

Bangaphezu kwe-150 abaxhamli bezindlu zaseMcGregor abasele bengene kumakhaya abo amatsha, njengoko iProjeki inkulu yeZindlu kuledolophu seyisondelela ekupheleni.

UMasipala waseLangeberg ngoku ulungiselela ukunikizela ngezitshixo kwabo bafanelwe kukufumana izindlu, njengoko izindlu ezigqityiweyo ziya zifumaneka.

Bonke abafanele ukufumana izindlu kuza kuqhagamshelwana nabo ngumasipala, nalapho khona igosa elisebenza ngezindlu liza kubacacisela ngenkukacha ezingenkqubo yokunikezelwa kwezindlu kubo.

UWilson Nel, uMlawuli weZindlu kuMasipala waseLangeberg, uthe leprojeki iquka malunga neeyunithi ezingama-496 zezindlu zenkxaso-mali, kodwa ngenxa yokuba bebengekho ngokwaneleyo abo baphunyezwe ukuba baxhamle, zezindlu ezingama-418 kuphela ezizakwaxhiwa okwangoku.

"Inani elizakushiyeka kwezinyunithi zingama-78. Ezilishumi kuzo zizakubekelwa bucala kulungiselelwa Isiza Esineenkonzo Eziphucukileyo zabo bafumana ama-R3501 ukuya R7 500 njengesibonelelo senkxaso-mali abazakuyifumana kubekanye. Ezinye ezingama-68 zezinyunithi zizakwaxhiwa xa kufunyenwe inani elaneleyo labantu

abafanelwe kukufumana izindlu," utshilo uNel.

Ezingama-418 zezinyunithi zizakubandakanya i-198 Lohlobo lweZindlu ezidibeneyo ezinemigangatho emibini kunye nezinye iiyunithi ezidibeneyo ezingama-220 ezinomgangatho omnye. Ezinye zezindlu zizakwaxhiwa ngendlela eyahlukileyo kulungiselela ezizakuxhamlwa ngabantu abakhubazekileyo.

Izindlu ezigqityiweyo kuza kuhlalwa kuzo phambi kokuphela konyaka. Abamxhamli abakhubazekileyo bona baza kuzifumana izitshixo zamakhaya abo phaya ngaboFebruwari kulo nyaka ulandelayo, ngoba kaloku ukuphunyezwa kweplani zezindlu kuthathe ixesha elide ngenxa yezongezelelo kuhlobo ezifanele ukwaxhiwa ngazo.

UNel uchaze ukuba leprojeki izakubonelela kuphela ingxenywe ethili yezidingo zezindlu zaseMcGregor nanjengoko izakunceda kuphela abobantu bomkela imali efikelela kuma-R3 500 ngenyanga.

Wongezelela ngelithi sisafunana neendlela esinokuzisebenzisa ukuncedisana nabangakwaziyo ukuhlangabezana nezidingo ezichanekileyo zokufumana indlu.

"Idingeko yezindlu isenkulu kakhulu noko kule nkqila. Bamalunga nama-9 285 abantu abakuluhlu lwamagama labalindele ukufumana izindlu olugcinwe

liPhondo," utshilo uNel.

Ngelinani liphezulu kangaka labantu Abakuluhlu Lwamagama Abantu Abalindele Ukufumana Izindlu eLangeberg, kuyacaca ukuba imiceli-mngeni ivela ngenxa yokukhula kwenkxalabo.

Eyona nto ikhethekileyo malunga naleprojeki yeyokuba ngaphandle kwezinyunithi zezindlu, ikwanazo nezinye iziza ezingama-35 ezongezelelweyo

zeentlobo ngeentlobo ezahlukeneyo zophuhliso. Olu phuhliso lutsha luzakuqhayisa ngeendawo ezivulekileyo zoluntu zokwenza iigadini zoluntu kwakunye neepaki, kanjalo neziko loluntu elizakuqeshiswa ngenjongo yokuphuhlisa uluntu.

Iprojeki yeZindlu yaseMcGregor kulindeleke ukuba igqitywe ekupheleni kukaFebruwari 2018, emvakoko bonke abaxhamli abafanelekileyo bazakuba bezifumane izindlu zabo ezintsha kraca.

Abanye babatyebileli baza kungxamela ukuyozifumanela ubumnandi kwiqula lokuqhuba kanti abanye bazakuya nje beyokonwabela imozulu yasehlotyeni kwindawo yokosa inyama neyepikiniki bekunye nezihlobo nosapho.

UDaniel Baadjies, uMlawuli: weePaki nokuZonwabisa kuMasipala waseLangeberg, ucacise ngelithi noxa amaqula okuqubha etsala amakhulukhulu abantu ngexesha leeholide zikaDisemba, bangama-432 kuphela abakwaziyo ukudada abanokungena ukuze libe liyagcwala. Daniel Baadjies, Bestuurder: Gemeenskapsfasiliteite by Langeberg Munisipaliteit, het verduidelik dat hoewel die swembad honderde mense gedurende die Desember-vakansie lok, kan slegs 432 swemmers op enige tydstep akkommodeer word voordat dit die kapasiteit bereik. Die hele fasiliteit kan egter 850 mense akkommodeer.

"Dit is belangrik dat alle besoekers hulself vergewis van die fasiliteit se reëls aangesien dit vir hul eie veiligheid is.

Wagte is aangewys om die swembadarea te patrolleer om te verseker dat alle swemmers veilig is en hulself op gepaste wyse gedra," het Baadjies gesê. 'n Nuwe draaihek sal by die ingang geïnstalleer word wat die munisipaliteit sal help met skarebeheer en die telling van besoekers.

Die huidige toegangsfooi per volwassene is R22.00 en vir kinders is dit R14.00.

Hy het bygevoeg dat die swembad se operasionele ure tussen 10:00 - 18:00 is en 12:00 - 18:00 op Sondag. Na 18:00 begin die voorbereiding vir die volgende dag, bv. byvoeg van chemikalieë.

Die swembad sal slegs oop wees tussen 1 Desember 2017 en 31 Januarie 2018 vanweë die bestaande waterbeperkings.

"Slegs mense wat swemkostuums dra, sal in die swembad toegelaat word. Jy sal nie toegelaat word om in jou jeans, t-hemp of onderklere te swem nie," het Baadjies gesê.

Daar is verskeie braai-areas vir besoekers.

SWIMMING POOL TO BE 'COOLEST DESTINATION' THIS SUMMER HOLIDAY



The public Swimming Pool in Robertson will welcome hundreds of visitors this month, making it once again one of the region's most popular hangout spots during the summer holidays.

Some of visitors will be eager to have a fun day in the pool and others will be arriving to enjoy the summer weather at the braai and picnic area with friends and family.

Daniel Baadjies, Manager: Community Facilities at the Langeberg Municipality, explained that although the swimming pool attracts hundreds of people during the December vacation period, only 432 swimmers can be accommodated at any given time before it reaches its capacity. The entire facility, however, can accommodate 850 people.

"It is important that all visitors familiarise themselves with the rules of the facility as it is for their own safety. Guards have been assigned to patrol the pool area to ensure that all swimmers are safe and conducting themselves appropriately," said Baadjies. A new turnstile will be installed at the entrance gate which will assist the municipality in crowd control and the counting of attendees.

The current entrance price per adult is R22.00 and for kids it's R14.00.

He added that the pool's daily operational hours are between 10:00 – 18:00 and from 12:00- 18:00 on Sundays. After 18:00 the preparation for the next day starts e.g. chemicals will be added.

The pool will only be open between 1st December 2017 and 31 January 2018 due to current water restrictions.

"Only people wearing swimming costumes will be allowed into the pool. You will not be allowed to swim in your jeans, T-Shirt or underwear," said Baadjies.

There are seven braai spots for visitors to use and a large lawn space for people to relax and have a picnic.

Use of the swimming pool area is done at own risk.

DO'S

- Report any bad behaviour
- Report vandalism
- Do have fun making use of the facility
- Call for help if you notice someone drowning
- Clean up after yourself

DONT'S

- No alcohol is allowed on the premises
- No glass containers are permitted on the Facility

- No pushing people in and around the pool
- Do not run around the pool
- No unnecessary or excessive noise
- Don't play roughly on the premises
- Don't swim alone
- Don't dive into the shallow side of the pool
- No surfboards, inflatable mattress, inner tubes or other objects that may cause injury or maybe an inconvenience to other in the swimming pool.
- Please don't use the pool as a toilet.

EDUCATIONAL FACTOR

- Spot the dangers
- Always swim within your ability
- Look out for yourself and other swimmers
- Do not swim if you have a gastrointestinal (stomach) upset or skin or respiratory infection
- Shower before you swim.

AWARENESS FACTORS

- Be aware of your own safety when entering the pool area
- Check the deep area where you can safely swim. The caution areas are marked eg. 4m deep allows for swimmers that have the ability to swim
- The pool will open from 1st December and close by 31 January due to severe drought and water shortages.

-  No filling of swimming pools.
-  No watering of sport fields, cricket pitches, golf course greens and/or bowling greens are permitted unless own source of water is used.

If you fail to comply, the municipality can
